Tradeview Europe Ltd. offers two account types depending on the deposit amount, ILC Type 7 for deposits below 1000\$ (or base currency equivalent) and ILC Type 5 for deposits equal or above 1000\$ (or base currency equivalent). Account currencies available USD and EUR.

#### Trading Commissions Forex/Metals

- MT4 or MT5 ILC Type 7 commissions are 3.5\$ (or base currency) per lot per side.
- MT4 or MT5 ILC Type 5 commissions are 2.5\$ (or base currency) per lot per side.

#### **Trading Commissions Indices**

• Both account types commission are 1\$ or base currency per lot contract.

#### Trading Commissions Crypto currency

- Both account types commissions are 0.15% of of the underlying Crypto currency
